In compliance with the requirements of the Global Forum of which HK is a member, the HK tax rules have been amended in 2010 and 2013 respectively. Up to Jan 2015, HK has signed up over 30 double tax agreements (DTA) and tax information exchange agreement (TIEA) with major jurisdictions, most of which has been HK's trading partner for a long time. It is this type of new developments that one is required to understand, in order to keep abreast of the changing external environment.

The materials of this seminar have been prepared and re-written for giving tailored-made lectures to PRC tax officials in major cities over the past 5 years. It covers the basic concepts, principles, and logics underlying the legal texts of the DTA and the TIEA under the OECD Model Tax Convention and Model Agreement on Exchange of Information on Tax Matters respectively.
