

**OUTSIDE AUTHOR AGREEMENT**  
**(No copyright transfer)**

This agreement by and between Alfred Chan (the “Author”), located at China Tax & Investment Consultants Ltd. in Hong Kong,, and Tax Analysts, a District of Columbia nonprofit corporation located at 400 South Maple Avenue, Suite 400, Falls Church, Virginia 22046, is effective on the date that the author signs it below. This agreement sets forth the terms and conditions of a license granted by author for all works of authorship created and submitted by the Author to Tax Analysts (each, a “Work”) during the 2017 calendar year (the “Term”) for publication in any Tax Analysts’ products and services.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Author agrees as follows:

Author hereby grants to Tax Analysts a perpetual, irrevocable, transferable, sublicensable, worldwide, fully paid-up and royalty-free right and license to use the Work (the “License”) and to exercise all rights of whatever kind or nature now or hereafter protected by the copyright laws of the United States of America and all foreign countries including, without limitation, the right to use, edit, publish, reproduce, distribute, display and transmit the Work in any and all format and media throughout the universe, including without limitation in any and all of Tax Analysts' products and services, and to sublicense others to use, publish, reproduce, distribute, display and transmit the Work in any and all format and media. For purposes of this paragraph, a "Tax Analysts' product or service" shall also include joint publishing, licensing or other arrangements with third parties.

Author hereby grants to Tax Analysts, and its successors, licensees and assigns, the right to use Author's name, image, likeness and biographical and professional information in connection with the Work.

It is understood the Author has not received, nor will Author receive, any royalty or other monetary compensation from Tax Analysts for the rights granted hereunder and the subsequent use of the work by Tax Analysts and it is further understood and acknowledged that the Author is not entitled to any such royalty or monetary compensation.

The Author represents and warrants that the submitted Work is original with the Author; that the Author has cleared rights to any portions of the work as reasonably may be expected or necessary for Tax Analysts to exercise its rights in the Work; that the Work does not violate any copyright, trademark, privacy or other legal rights of any third party; that to the best of the Author's knowledge, all underlying facts contained in the Work are accurate, that the Work does not contain any libelous or scandalous material and that the Author will promptly report any disputes over facts to their editor, so that corrections can be made; and that the Author is free to enter into this agreement without the violation of any contractual, employment or other legal obligations that the Author may have related to the submitted Work.

Without limiting the generality of the foregoing, the Author agrees and acknowledges that for a period of twenty-eight (28) days from the date of first publication of any Work to Tax Analysts' subscribers, the License shall be exclusive ("Exclusive License Period") to Tax Analysts. During the Exclusive License Period, the Author shall not republish or authorize a third party to publish any Work unless done so with the express consent of Tax Analysts. After the expiration of the Exclusive License Period, the License shall be non-exclusive.

Author acknowledges at all times that Author is an independent contractor and nothing in this agreement shall make either party the agent of the other. Except as otherwise provided herein, each party shall bear its own costs and expenses.

Tax Analysts may terminate this agreement for any reason upon 30 days written notice to the Author.

This Agreement shall be governed by the laws of the Commonwealth of Virginia, without reference to its conflict of laws principles, and the parties hereby submit to the jurisdiction and venue of the Federal and State courts situated in the Eastern District of Virginia with respect to any dispute arising under or related to this Agreement.

Notwithstanding any termination of this Agreement, the representation and warranties provision, and governing law and venue provisions shall survive such termination.

**THIS AGREEMENT CONSTITUTES THE ENTIRE AGREEMENT BETWEEN THE PARTIES WITH RESPECT TO THE SUBJECT MATTER HEREOF. AS OF THE EFFECTIVE DATE, ALL PRIOR AGREEMENTS, REPRESENTATIONS, COMMITMENTS, NEGOTIATIONS, OR UNDERSTANDINGS CONCERNING THE SAME SUBJECT MATTER ARE SUPERSEDED BY THIS AGREEMENT.**
